BEGINNING AT A STAKE IN THE CENTER OF THE BETHLEHEM CHURCH ROAD AT BARKER'S ORIGINAL SOUTHEAST CORNER ON P.M. PITZER'S NORTH LINE; THENCE NORTH WITH THE CENTER OF SAID ROAD 26 POLES, 23 LINKS TO A STAKE IN THE CENTER OF SAID ROAD, THE BEGINNING SE CORNER OF THE BETHLEHEM CHURCH LOT; THENCE WEST 18 POLES WITH BARKER'S NORTH LINE TO A STAKE; THENCE SOUTH 4 1/3 POLES WITH BARKER'S EAST LINE TO A STAKE; THENCE WEST 20 POLES WITH BARKER'S NORTH LINE TO A STAKE (THE SW CORNER OF BETHLEHEM'S CHURCH LOT); THENCE NORTH 1 1/2 DEGREES WEST 24 1/3 POLES WITH BARKER'S EAST LINE TO A STAKE (THE NW CORNER OF BETHLEHEM CHURCH LOT AND AN INSIDE CORNER OF BARKER'S); THENCE NORTH 69 3/4 DEGREES EAST 39 POLES, 5 LINKS WITH BARKER'S SOUTH LINE TO A STAKE IN THE CENTER OF BETHLEHEM ROAD AT BARKER'S SOUTHEAST CORNER; THENCE SOUTH 3 DEGREES 23 MINUTES 6 SECONDS EAST WITH THE CENTER OF BETHLEHEM ROAD 553.75+/- FEET TO THE BEGINNING CORNER CONTAINING 6.81 MORE OR LESS ACRES.

BEGINNING AT A STAKE IN THE CENTER OF THE BETHLEHEM CHURCH ROAD AT BARKER'S ORIGINAL SOUTHEAST CORNER ON P.M. PITZER'S NORTH LINE; THENCE NORTH WITH THE CENTER OF SAID ROAD 26 POLES, 23 LINKS TO A STAKE IN THE CENTER OF SAID ROAD, THE BEGINNING SE CORNER OF THE BETHLEHEM CHURCH LOT; THENCE WEST 18 POLES WITH BARKER'S NORTH LINE TO A STAKE THE BEGINNING CORNER OF THE TRACT BEING CONVEYED; THENCE SOUTH 4 1/3 POLES WITH BARKER'S EAST LINE TO A STAKE; THENCE WEST 20 POLES WITH BARKER'S NORTH LINE TO A STAKE (THE SW CORNER OF BETHLEHEM'S CHURCH LOT); THENCE NORTH 1 1/2 DEGREES WEST APPROXIMATELY 174 FEET WITH BARKER'S EAST LINE TO A STAKE, AT THE NW CORNER OF THE CEMETARY LOG: THENCE EAST APPROXIMATELY 330 FEET MAKING A NEW LINE THROUGH THE BETHLEHEM CHURCH PROPERTY TO A STAKE; THENCE SOUTH 1.5 DEGREES EAST APPROXIMATELY 102.55 FEET MAKING A NEW LINE THROUGH THE BETHLEHEM CHURCH PROPERTY TO THE BEGINNING CORNER.

INGRESS AND EGRESS EASEMENT TO CEMETARY

BEGINNING AT A STAKE IN THE CENTER OF THE BETHLEHEM CHURCH ROAD AT BARKER'S ORIGINAL SOUTHEAST CORNER ON P.M. PITZER'S NORTH LINE; THENCE NORTH WITH THE CENTER OF SAID ROAD 26 POLES, 23 LINKS TO A STAKE IN THE CENTER OF SAID ROAD, THE BEGINNING SE CORNER OF THE BETHLEHEM CHURCH LOT; THENCE WEST 18 POLES WITH BARKER'S NORTH LINE TO A STAKE; THENCE NORTH 30 FEET ALONG THE EAST LINE OF THE CEMETARY LOT MAKING A NEW LINE THROUGH THE BETHLEHEM CHURCH PROPERTY TO A STAKE; THENCE EAST 297 FEET MAKING A NEW LINE THROUGH BETHLEHEM CHURCH PROPERTY TO A STAKE IN THE CENTER OF BETHLEHEM ROAD; THENCE SOUTH 30 FEET WITH THE CENTER OF SAID ROAD TO THE BEGINNING CORNER.
